He will explain the basics in network security. Ms. Schnur will dive into the latest statistics and legal issues surrounding privacy, including a brief discussion of what can be covered with an insurance policy and what gaps in coverage you need to know about.

Alan Brill is senior managing director for Kroll Advisory Solutions. He consults with law firms and corporations on investigative issues relating to computers and digital technology, including the investigation of computer intrusions, Internet fraud, identity theft, misappropriation of intellectual property, cases of internal fraud, data theft, sabotage and computer security projects designed to prevent such events. He has worked extensively on developing methodologies for collecting evidence from corporate information systems.

As the founder of Kroll's global high-tech investigations practice, his work has ranged from large-scale reviews of information security and cyber-incidents for multi-billion dollar corporations to criminal investigations of computer intrusions. He has worked on many of Kroll's major international projects. With more than 33 years of consulting experience, he has assisted firms with a wide range of technology security issues.

Brill is author and co-author of five books and has also written myriad articles for national and international publications. He has appeared in a wide range of media outlets as a subject matter expert, including 60 Minutes; Dateline NBC; Good Morning America; Time Magazine; US News and World Report; Wall Street Journal; USA Today; NBC, CBS and ABC News; as well as CNN, MSNBC, CNBC, BBC, A&E, CBC, Discovery Networks and Court TV.

He has been an instructor for the FBI, Secret Service, Federal Law Enforcement Training Center, AICPA, ABA, John F. Kennedy School of Government at Harvard and the NATO Center of Excellence — Defense Against Terrorism. He has testified in state and federal courts, as well as before congressional and federal agency committees. He has served as a Special Master for the federal courts.

Meredith Schnur serves as an in house resource for all professional liability, technology errors & omissions, media, network security and privacy related lines of coverage. In her role, she provides consultative services, market negotiations, policy analysis and placement, policy administration and claims advocacy services. Additionally, Meredith serves as PRG's National Product Leader for the Technology, Privacy and Network Risk Practice.

Before joining Moody's, Dan spent 15 years with The Bank of New York, where he was a Vice President and Group Head with responsibilities for credit and relationship management in several industries. Dan holds an M.B.A. in finance from New York University and a B.A. in economics from the University of Rochester.

Diane Vazza is Head of Global Fixed Income Research at Standard & Poor's. Her analyses, forecasts and research on global credit markets have earned her an international audience and she is widely quoted in the financial media, including the Wall Street Journal, Financial Times, New York Times, CNBC, Bloomberg and ThomsonReuters.
