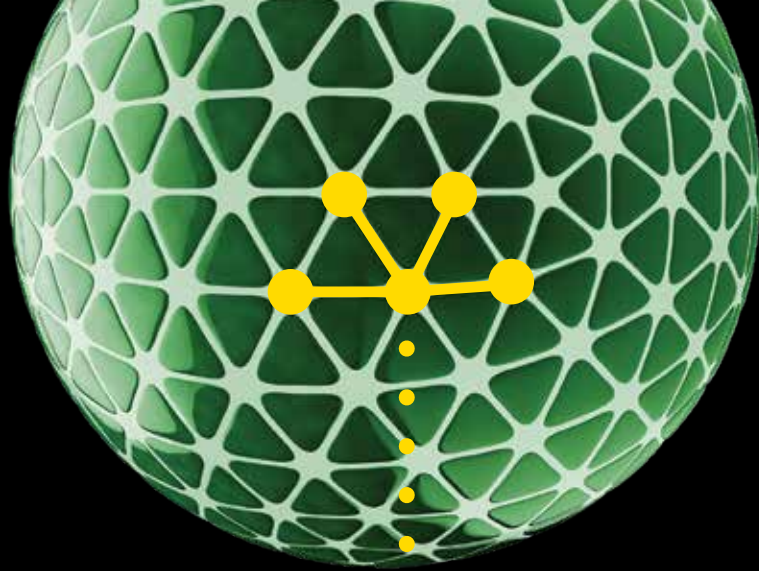

ABOUT THE NACT

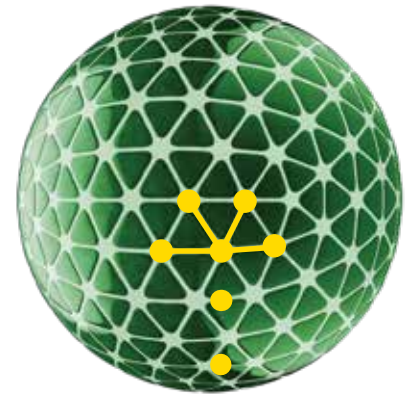


**A Member-Driven
